Resolution Ratifying the Federal Charter of Incorporation for the Financial Freedom Service Products, Inc.

- WHEREAS, the Tunica-Biloxi Tribe of Louisiana (the "Tribe") is a federally-recognized Indian tribe;
- WHEREAS, the Tunica-Biloxi Tribal Council ("Tribal Council") is the duly elected governing body of the Tribe, as authorized by Article VII, Section 1, of the Constitution of the Tribe ("Constitution");
- WHEREAS, the Tribal Council has the authority and responsibility to supervise and manage Tribal economic affairs and enterprises and to administer all property of the Tribe;
- WHEREAS, the Tribal Council has the power and authority under the Constitution to establish and regulate component parts or "arms" of the Tribe and subordinate organizations for business purposes;
- WHEREAS, the Tribe has the inherent governmental power to create, certify, own, oversee and regulate such arms of the Tribe and business entities, including limited liability companies and corporations;
- WHEREAS, the Tribe has the power to pass and enact laws in the exercise of the Tribe's sovereignty, and pursuant to Article VIII, Section 1(L) of the Constitution, this power is delegated to the Tribal Council;
- WHEREAS, on June 17, 2016, pursuant to Tribal Council Resolution 06-17-16, the Tribal Council passed a "Resolution Approving a Section 17 Federal Corporate Charter for Financial Freedom Service Products, Inc., and Authorizing the Tribal Chairman, on Behalf of the Tribal Council, to Petition the Secretary of the Interior to Issue the Charter;"
- WHEREAS, The Federal Charter of Incorporation was issued March 30, 2017 by the Department of the Interior to the Tunica-Biloxi Tribe of Louisiana for Financial Freedom Service Products, Inc., pursuant to the Indian Reorganization Act of 1934, as amended, 25 U.S.C. § 461 et seq., Section 17 of which (25 U.S.C. §477), authorizes the Secretary of the Interior to issue federal corporate charters to Indian tribes; and
- WHEREAS, the Federal Charter of Incorporation for Financial Freedom Service Products, Inc., requires ratification by the Tribal Council to become effective
- **NOW, THEREFORE BE IT RESOLVED**, that the Tribal Council hereby ratifies the Federal Charter of Incorporation for Financial Freedom Service Products, Inc., and directs the Chairman to make all relevant filings and notifications on behalf of the Tribe.

WHEREAS, the Tunica-Biloxi Tribe of Louisiana (the "Tribe") is a federally-recognized Indian Tribe, governed by the Tunica-Biloxi Tribe of Louisiana Tribal Council (the "Tribal Council"), the duly elected governing body of the Tribe, as authorized by Article VII, Section 1, of the Constitution of the Tunica-Biloxi Tribe of Louisiana (the "Constitution");

WHEREAS, the Tribal Council has the enumerated power and responsibility to "promote and protect health, peace, morals, education, and the general welfare of the Tribe, as authorized by Article VIII, Section 1(G), of the Constitution;

WHEREAS, the Tribal Council has the authority and the responsibility to act on behalf of the Tunica-Biloxi Tribe of Louisiana to pass laws and resolutions necessary or incidental to the exercise of any of its delineated powers;

WHEREAS, United South and Eastern Tribes, Inc. (USET) is an organization composed of thirty-three (33) federally recognized Tribes;

WHEREAS, USET provides important services and functions to promote the common interests of its member Tribes;

WHEREAS, it is vitally important that USET continue to promote the unity of its member Tribes;

WHEREAS, Tribe is a member of USET and is committed to the preservation of USET as an effective organization;

WHEREAS; USET has offered to provide services and information that are beneficial to the Tribe; and

WHEREAS, as stipulated in the USET Bylaws, each of the member Tribes listed in Section 2 of this Article shall be responsible for General Support in the amount of \$12,000.

THEREFORE, BE IT RESOLVED, the Tribe does hereby authorize the full payment of the FY2021 General Support dues to USET in the amount of \$12,000.

TUNICA-BILOXI TRIBE OF LOUISIANA RESOLUTION NO. TBNR-2021-009

A RESOLUTION OF THE TRIBAL COUNCIL OF THE TUNICA-BILOXI TRIBE OF LOUISIANA (THE "TRIBE") (i) RECOGNIZING THE CREATION OF THE TUNICA_BILOXI ECONOMIC EMPOWERMENT AUTHORITY; AND (ii) GRANTING ROY HOLLEMAN ADMINISTRATIVE RESPONSIBILITY AND AUTHORITY TO ACT ON BEHALF OF THE AUTHORITY AND SIGNATORY AUTHORITY AT THE AUTHORITY'S FINANCIAL INSTITUTIONS

WHEREAS, the Tribe is a federally recognized Indian tribe and the Tunica-Biloxi Tribal Council (the "Tribal Council") is the duly-elected governing body of the Tribe, as authorized by Article VII, Section 1, of the Constitution of the Tribe; and

WHEREAS, under the Constitution, the Tribal Council has the power to supervise andmanage tribal economic affairs and enterprises in accordance with the Constitution and tribal laws; to administer all property of the Tribe; to establish and regulate subordinate organizations for business purposes; and to pass laws and resolutions incidental to the exercise of any powers of the Tribal Council expressly stated in the Constitution; and

WHEREAS, the Tribal Council may also exercise all other inherent tribal powers not expressly delegated pursuant to the Constitution; and

WHEREAS, Article VIII, Section I(E) of the Constitution authorizes the Tribal Council to supervise and manage tribal economic affairs and enterprises; Article VIII, Section 1(H) thereof authorizes the Tribal Council to administer all property of the Tribe; Article VIII, Section 1(J) thereof authorizes the Tribal Council to establish and regulate subordinate organizations for social and business purposes; and Article VIII, Section 1(L) thereof authorizes the Tribal Council to pass laws and resolutions necessary or incidental to the exercise of any of the Tribal Council's powers listed in Article VIII; and

WHEREAS, on June 17, 2016 the Tribal Council voted to petition the Secretary of the Interior to issue an amended and restated federal charter of incorporation to the Tribe to establish a business corporation as authorized by Section 17 of the Indian Reorganization Act; and

WHEREAS, the Tribal Council has found that the formation of Financial Freedom, Inc. (the "Corporation") pursuant to a §17 charter serves the best interests of the Tribe, its members and its enterprises and protects the political integrity, economic security and health and welfare of the Tribe and its members by, among other things, creating a legal structure that provides for (1) the segregation of Tribal governmental assets and liabilities from Tribal business assets and liabilities, and (2) the segregation of discrete Corporation assets and liabilities into

WHEREAS, on, March 31, 2017 the Bureau of Indian Affairs, Eastern Regional Office, acting pursuant to delegated authority from the Secretary of the Interior, approved and issued the Section 17 Federal Charter of Incorporation for the Corporation ("Charter"); and

WHEREAS, on March 11, 2021, pursuant to Tribal Council Resolution TBN-R-2021-07, the Tribal Council ratified the Charter; and

WHEREAS, Article V, Section A of the Charter provides that the Corporation shall be wholly owned by the Tribe for the benefit of the Tribe and its members; and

WHEREAS, Article V, Section C provides that the rights of the Tribe as owner of the Corporation shall be exercised by the Tribal Council in accordance with this Charter and applicable Tribal law, and that no individual member of the Tribal Council or individual member of the Tribe or any other person whomsoever shall be recognized as acting as or on behalf of the Tribe as owner; and

WHEREAS, Article V, Section C of the Charter provides that the sole right and authority to represent the Tribe as owner of the Corporation shall be vested in the Tribal Council;and

WHEREAS, the Tribal Council has determined that it is in the Tribe's and the Corporation's best interests to authorize the Chairman of the Tribe to act on behalf of the Tribal Council acting on behalf of the Tribe as owner of the Corporation and the Chairman has decided that Financial Freedom (FFI) should create the Tunica-Biloxi Economic Empowerment Authority (TBEEA) as an LLC under the umbrella of FFI and that TBEEA should direct its efforts towards vocational and job training for Tribal members through the manufacturing of personal protective equipment; and

WHEREAS, the Tribal Council has determined that it is in the Tribe's best interests to grant Mr. Roy Holleman administrative responsibility and authority to act on behalf of the TBEEA, including without limitation, the authority to maintain control of all records and documents related to the TBEEA; and

WHEREAS, the Tribal Council has also determined that it is in the Tribe's and the Corporation's best interests to grant Mr. Roy Holleman signatory authority at any financial institution that he deems necessary to the operation of TBEEA for all financial and investment matters related to the TBEEA.

WHEREAS, the Tribal Council has also determined that it is in the Tribe's and the Corporation's best interests to grant Roy Holleman, Clarence Brown, James T. Martin, and Wendy Lemoine signatory authority at any financial institution that is created on the behalf of TBEEA for all financial and investment matters.

NOW, THEREFORE, BE IT RESOLVED that the Tribal Council, as the governing body of the Tribe and pursuant to the laws and sovereign authority of the Tribe, and as the representative of the Tribe, the sole owner of the Corporation, hereby (i) authorizes the Chairman of the Tribe, for and on behalf of the Tribal Council acting on behalf of the Tribe as owner of the Corporation, to direct FFI to create TBEEA; and (ii) grants Mr. Roy Holleman administrative responsibility and authority to act on behalf of the Corporation, including without limitation, the authority to maintain control of all records and documents related to the Corporation, and signatory authority any financial entity he deems necessary for TBEEA for all financial and investment matters related to TBEEA.
