This communication was sent a couple of weeks ago in anticipation of a Council meeting on 3/11/21. However, that meeting was postponed until 3/25/21. This memo and the attached listing of Council actions with a complementary PPT is being sent again as a reminder to the Council about the upcoming discussion and to allow each of you time to review the information and be fully prepared to take final actions on these points. Once the Council does that, Fran will be able to create the draft MTD, the 3rd Amended & Restated version of this document that primarily governs the Trust Program of the Tunica-Biloxi Indian Tribe of Louisiana for final approval by the Council Members.

The attached listing contains items that were approved by the Tribal Council during their meeting on Thursday, February 11, 2021, with myself and Fran O'Neal of the Laborde Law Firm.

Items # 1, 4, 5, 6, 7, 8, 10, 13, 14, and 15, were approved by a vote or by general consensus with no objections.

Items # 2, 3, 9, 11, and 12, still require a Tribal Council decision.

I have included all the items in this list for clarity and recall, and I would like for the Council to conduct a vote on the entire list to minimize confusion in the future when anyone tries to research actions associated with this updated version of the MTD.

If there are any items that the Council does not wish to approve or authorize, we can simply strike them from the list and have a vote conducted on the remaining items. The Power Point presentation highlights the issues that require action, and it has some charts and graphs to facilitate our discussion.

Final Decisions from Council RE: MTD revisions, v.2: Council Meeting_3-25-2021

- 1. Official name of the tribe for the MTD? Tunica-Biloxi Indian Tribe of LA. YES.
- 2. Chain of inheritance: does the Council want to retain the parents in the line of inheritance? Keep in mind, these funds are meant for tribal minors, not tribal adults, per the Revenue Distribution/Allocation Plan approved by the BIA. YES or NO?
- 3. There was some conversation about modifying the distribution plan so we could limit disbursements to \$15K and get more funds flowing to the lower end of tribal minors, but that is not allowed under the RDP...you cannot break up a class. The RDP specifically and particularly allows for the designation of this 'class' of per capita recipients. YES or NO? (Has to be NO.)
- 4. The new threshold floor is \$20K with a goal to get all minors up to \$20K, if at all possible, in the Tribe's current and future economic environments. YES.
- 5. Financial Education Sessions: minimum of semi-annual sessions; goal of quarterly sessions. YES.
- 6. Adult beneficiaries do not need their parents'/guardian's permission to access their trust if over the age of 18. YES.
- 7. Parents'/legal guardian's income should not be considered if a beneficiary is over 18 and applies to access his/her trust. YES.
- 8. Retain the language allowing for charitable contributions by a trust if beneficial to that trust, from a tax perspective. YES.
- 9. Tax preparation: delegate to families IF they desire to do so. HOWEVER, they must submit a copy of the minor's tax return to the tribe. Why? IGRA, tribe's obligation to protect and preserve. We need to be sure the parents are filing in order to protect the beneficiaries in the future as they close out their accounts. YES or NO?
- 10. Draft Beneficiary Form for an adult beneficiary to declare who will inherit their trust if they pass between ages of 18-21, or will it be 18-25? YES.
- 11. Does Council want to raise the closure age to 25, allowing for a 50% distribution of a trust at age 21, and then the balance to be distributed upon reaching the age of 25? YES or NO?

- 12. If the Council approves the delayed closure, what is an adult beneficiary able to do between 18 & 25?
 - a. Can they access remaining funds for a...
 - i. home purchase,
 - ii. a vehicle purchase,
 - iii. educational pursuits (accredited programs), etc. YES or NO?
 - b. Should there be any restrictions, b/c if not, what's the point of establishing a higher closure date if they are allowed to tap the trust with no limits in the interim? YES or NO?
- 13. Retain language in Section 7.14.a, allowing the Settlor to be reimbursed for any tax payment it makes on behalf of a trust. YES.
- 14. Draft 'Tribal Power of Attorney' document to be used for purposes set forth in the revised MTD. (Or for any other legal matter within the tribe where a POA is called for.) YES.
- 15. Trust Accounts for Minors from the time of enrollment up to 18yrs of age will be restricted from making any distributions other than for medical needs of the beneficiary. YES.

Structure and Timing for Tunica-Biloxi Council Governance Workshop

DATE:

In follow up to our conversations about the structure and timing of a governance workshop with the Tunica-Biloxi Tribal Council, I would propose a three-part approach that would allow for more discussion and for the development of the ideas and concepts the Council would like to address. In my experience, it is hard to work through and develop strategies to address major issues in just one session.

Set forth below are the three elements of my proposal:

Initial Calls. When I have led similar workshops in the past, I have found it very useful to talk to the participants individually in advance of the group meeting to identify their areas of interest or concern. This allows me to prepare better, build rapport, develop appropriate materials, and tailor the workshop to the Council's actual needs. These calls could begin immediately and would likely span a week or two. Total time: approximately 10 hours.

Virtual Session(s). In my experience, you can only work through the issues effectively if there is more than one session, which allows the participants to become educated and to think through what they have heard and discussed, and then come back with more developed views. Also, because I do not wish to travel until I have received the COVID vaccine, this is a way to engage in important preliminary conversations before a longer in-person session. Virtual sessions could begin any time after the calls have been completed, so likely late March or early April.

In-Person Meeting. I hope to have received the vaccine by the end of April, so I would tentatively propose an in-person session by mid-May. Total time: for both virtual and in-person, approximately 20 hours.

Follow-Up. After the meeting, I would provide a written report with recommendations if appropriate. *Total time: approximately 10 hours.*

Compensation. I propose a flat rate of \$16,000 plus travel and related expenses (this is based on 40 hours x \$400/hour).

Of course, I want to accommodate the Council to the maximum extent possible and am happy to discuss and revise this approach as needed.
