- WHEREAS, the Tunica-Biloxi Tribal Council has the authority and responsibility to act on behalf of Tunica-Biloxi Tribal members regarding their general welfare; and
- WHEREAS, the Tunica-Biloxi Tribal Council desires to consolidate the various reporting activities of its authorities, commissions, boards, instrumentalities and all other entities established under Tribal law; and

NOW THEREFORE BE IT RESOLVED, the Tribal Council hereby approves the following reporting schedule for the Tunics-Biloxi Tribe of Louisiana:
