A RESOLUTION AUTHORIZING THE USE OF ELECTRONIC AND DIGITAL SIGNATURES

- WHEREAS, the Tunica-Biloxi Tribe of Louisiana is a federally recognized Indian tribe; and
- WHEREAS, the Tunica-Biloxi Tribal Council ("Tribal Council") is the duly elected governing body of the Tribe, as authorized by Article VII, Section 1, of the Constitution of the Tribe ("Constitution"); and
- **WHEREAS**, the Tribal Council is empowered by Articles VII and VIII of the Constitution to enact codes necessary to fulfill its enumerated powers and other codes incidental to the exercise of its enumerated powers; and
- WHEREAS, the Tribal Council has the authority and responsibility to act on behalf of Tunica-Biloxi Tribal members regarding their general welfare; and
- WHEREAS, the Tribal Council seeks to modernize operational functions of the Tunica-Biloxi Tribal government by implementing the use of electronic and digital signatures for official tribal business; and
- WHEREAS, the use of electronic and digital signatures, where appropriate and permitted by applicable law, will lessen administrative demands, improve efficiency, increase access to information for all Tribal citizens, leverage the Tribe's investments in digital technology, and provide for predictable processes throughout the Tribal Government; and
- **THERFORE BE IT RESOLVED,** the use of electronic and digital signatures shall be authorized and permitted for the execution of official tribal business, including the approval of contracts, agreements, transactions, minutes, documents, and other records of the Tunica-Biloxi Tribe of Louisiana; and
- **BE IT FURTHER RESOLVED,** the use of electronic and digital signatures shall have the same force and effect as a manual signature under Tribal law; and
- **BE IT FINALLY RESOLVED,** this Resolution shall become effective within thirty (30) days of approval by the Tribal Council.
