#### **SUMMARY:**

Responsible for the deep cleaning of the stove hoods, equipment and floors in assigned food preparation venues when restaurant is closed for operation in accordance with Paragon Casino Resort specifications and standards. Also responsible for ensuring china, glassware, silverware is cleaned efficiently and promptly providing all facets of the dining venue available stock of silver and dishware on a continual basis.

#### **ESSENTIAL DUTIES AND RESPONSIBILITIES** include the following:

- Cleans all walls, surface of hoods, drains, rack areas and under equipment in food preparation areas.
- Cleans kitchen equipment and kitchen grills after all food is removed.
- Maintains cleanliness around the exterior loading dock areas.
- Cleans interior wall of kitchens.
- Ensures adherence to all OSHA safety requirements, MSDS and company safety policies.
- Ensures compliance to standards set by management in scraping, racking, stacking and washing of china, glassware and silverware.
- Responsible for keeping work area clean and sanitary. Assists in maintaining standards of health, safety and sanitation.
- Ensures set up and break down of dishwasher and pot washer, maintains proper temperature.
- Participates as a team member with food servers, cooks, supervisor and any pertinent Paragon Casino associates in producing a smoothly and efficiently run operation that meets the highest standards of guest services.
- Performs other duties as assigned.

***Paragon Casino Resort requires all Associates to consistently:***

- To perform this job successfully, an individual must be able to perform each essential duty satisfactorily.
- Exceed Guests expectations with quality and friendly service.
- Treat all Associates and Guests with respect, dignity, integrity and sensitivity.
- Provide a safe working environment by complying with safety rules and reporting potential hazards.
- Comply with company performance standards and departmental policy and practices.
- Demonstrate pride and professionalism for the property, its goals and the Associate Pledge.
- Support training and development for all Associates.
- Communicate and share ideas, concerns and explain “Why” behind decisions.
- Maintain a consistent, regular attendance record.

**REQUISITE QUALIFICATIONS:**

**Education and/or Experience:** High school diploma or general education degree (GED) preferred. Previous experience preferred. In house training will be provided.

**Qualifications:** Strong organizational and interpersonal skills required.

**Must apply for, be granted and retain a valid Tribal Gaming License during their employment with Paragon Casino Resort. Must have understanding of and abide by all regulations as stated in the Tribal-State Compact.**

**Language Skills:** Ability to read and interpret documents such as safety rules, operating and maintenance instruction, and procedure manuals. Ability to respond to common inquiries or complaints. Ability to read and comprehend simple instructions, short correspondence and memos.

**Mathematical Skills:** Ability to work with mathematical concepts such as addition, subtraction and multiplication tables.

**Physical Demands:** The physical demands described here are representatives of those that must be met by an Associate to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the Associate is regularly required to talk or hear. The Associate is also regularly required to stand; walk; sit; and use hands to finger, handle or feel objects, tools, or controls. The Associate is occasionally required to reach with hands and arms, and to sit; climb or balance; and stoop, kneel, crouch or crawl.

The Associate is required to lift and/or move up to seventy-five (75) pounds.

Must be able to bend, lift equipment, and climb a twelve (12) foot ladder.

Specific vision abilities required by this job include close vision, distance vision, peripheral vision, depth perception, and the ability to adjust to focus.

While performing the duties of this job, the Associate regularly works near moving mechanical parts.

The noise level in the work environment is usually moderate to loud. The casino environment is usually smoky.
