#### **SUMMARY:**

Responsible for providing dining service to all guests of Tamahka Trails Golf Course in an efficient, courteous and professional manner displaying a high standard of guest services.

#### **ESSENTIAL DUTIES AND RESPONSIBILITIES** include the following:

- Responsible for prompt, efficient and courteous service of food and beverages to restaurant guests in accordance with venue standards.
- Performs necessary tasks to service guests, i.e.; taking and filling all food and drink orders and executing the steps of service as required by the facility supervisor or manager. This also includes assisting in maintaining guests dining area in a clean and neat manner such as vacuuming floors, cleaning tables, chairs, windows and all surfaces.
- Responsible for finishing and/or garnishing food in the kitchen in accordance with paragon specifications and standards.
- Monitors guests' needs on a continual basis ensuring all requests will be promptly fulfilled.
- Maintains current knowledge of all menu items and ingredients and knowledge of basic beverage services including alcoholic drinks.
- Serves alcoholic and non-alcoholic beverages to Guest at the Grill bar.
- Provides beverage cart service on the golf course and operates in safe manner and in compliance with company policies and procedures.
- Accurately records all transactions on the POS system and handling of cash.
- Performs as a team member with supervisors, food servers, and kitchen staff in producing a smooth and efficiently run operation.
- Assists other restaurant personnel with maintenance (side work, opening/closing duties) as necessary.
- Performs other duties as assigned.

**Language Skills:** Ability to read and interpret documents such as safety rules, operating and maintenance instruction, and procedure manuals. Ability to write routine reports and correspondence. Ability to speak effectively before groups of guests or Associates of the organization.

**Mathematical Skills:** Ability to add and subtract two digit numbers and to multiply and divide with 10's and 100's. Ability to perform these operations using units of American money.

**Reasoning Ability:** Ability to define problems, collect data, establish facts, and draw valid conclusions. Ability to interpret an extensive variety of technical instructions in mathematical or diagram form and deal with several abstract and concrete variables.

**Physical Demands:** The physical demands described here are representatives of those that must be met by an Associate to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the Associate is regularly required to talk or hear. The Associate is also regularly required to stand; walk; sit; and use hands to finger, handle or feel objects, tools, or controls. The Associate must frequently lift and/or move up to 25 lbs.
