Tahch'i Farm is seeking reliable seasonal contract workers for the growing season (**April through June 2026**). Work hours will be up to **40 hours per month at \$10 to \$12/hour**. While this position is intended to run through June, it may be extended beyond June on an as-needed basis, subject to farm requirements.

- Comfortable working outdoors in various weather conditions.
- Able to lift up to 40 pounds and perform manual farm tasks (e.g., planting, weeding, harvesting).
- Previous farm or gardening experience preferred but not required.
- Dependable, punctual, and able to follow instructions with minimal supervision.
