**SUMMARY:**

Responsible for effectively coordinating and directing the activities of the Club Paragon on an assigned shift.

**ESSENTIAL DUTIES AND RESPONSIBILITIES** include the following:

- Supervises CLUB PARAGON Representatives, to ensure smooth and efficient service is provided to guests.
- Promotes CLUB PARAGON , by assisting guests through the membership process.
- Assists Shift Managers and Casino Hosts, as needed, with CLUB PARAGON related matters.
- Facilitates the flow of information throughout the department, by attending regularly scheduled meetings and conveying accurate information to Associates on assigned shift.
- Resolves problems which relate to CLUB PARAGON .
- Ensures that all edits and audits of CLUB PARAGON information are completed in a timely manner.
- Maintains accurate departmental records, and regularly reports relevant information in CLUB PARAGON Club Manager.
- Ensures a maximum level of guest service and satisfaction in CLUB PARAGON is achieved and maintained.
- Regularly inspects stock of CLUB PARAGON printed material, milestone gifts, supplies and re-stocks same, as needed.

**SUPERVISORY RESPONSIBILITIES:**

Directly supervises the activities of all CLUB PARAGON Associates on an assigned shift.

**REQUISITE QUALIFICATIONS:**

The requisite qualifications listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

**Education and/or Experience:** High school diploma or general education degree (GED) required and 3-5 years experience in guest service role, preferably in a casino environment.

**Qualifications:** Must possess excellent communication and organizational skills. One to three years of applicable customer-relations experience, with progressive supervisory experience, required. Must be familiar with, and able to operate computers, printers, and cardpunch machines.

**Must apply for, be granted and retain a valid Tribal Gaming License and State Gaming Certification during their employment with Paragon Casino Resort. Must have understanding of and abide by all regulations as stated in the Tribal-State Compact.**

**Language Skills:** Ability to read, analyze, and interpret simple documents, such as safety rules, operating and maintenance instructions, and procedure manuals. Ability to write routine reports and correspondence. Ability to effectively present information in one-on-one and small group situations to guest and other Associates of the company.

**Mathematical Skills:** Ability to add, subtract, multiply and divide in all units of measure, using whole numbers, common fractions, and decimals.

**Reasoning Ability:** Ability to apply commonsense understanding to carry out instructions furnished in written, oral, or diagram form. Ability to deal with problems involving several concrete variables.

**Physical Demands:** The physical demands described here are representatives of those that must be met by an Associate to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the Associate is regularly required to talk or hear.

The Associate is also required to stand, sit, and use hands to finger, handle, or feel objects, tools, or controls. The Associate occasionally is required to reach with hands or arms, and to sit; climb or balance; and stoop, kneel, crouch, or crawl.

The Associate must frequently lift and/or move up to twenty five (25) pounds.

Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception, and the ability to adjust focus.

**WORK ENVIRONMENT:** The work environment characteristics described here are representative of those an Associate encounters while performing the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

The noise level in the work environment is usually moderate to loud. The casino environment is usually smoky.
