#### **SUMMARY:**

Responsible for ensuring china, glassware, silverware is cleaned efficiently and promptly providing all facets of the dining venue available stock of silver and dish ware on a continual basis.

#### **ESSENTIAL DUTIES AND RESPONSIBILITIES** include the following:

- Ensures compliance to standards set by management in scraping, racking, stacking, and washing of china and glassware.
- Responsible for keeping work area clean and sanitary.
- Assists in maintaining standards of health, safety, and sanitation.
- Participates as a team member with Food Servers, Utilities, Cooks, Supervisor and any pertinent Paragon Casino Associate in producing a smoothly and efficiently run operation that meets the highest standards of Guest Services.
- Performs other non-gaming duties as assigned.

#### ***Paragon Casino Resort requires all Associates to consistently:***

- To perform this job successfully, an individual must be able to perform each essential duty satisfactorily.
- Exceed Guests expectations with quality and friendly service.
- Treat all Associates and Guests with respect, dignity, integrity and sensitivity.
- Provide a safe working environment by complying with safety rules and reporting potential hazards.
- Comply with company performance standards and departmental policy and practices.
- Demonstrate pride and professionalism for the property, its goals and the Associate Pledge.
- Support training and development for all Associates.
- Communicate and share ideas, concerns and explain "Why" behind decisions.
- Maintain a consistent, regular attendance record.

#### **REQUISITE QUALIFICATIONS:**

The requisite qualifications listed below are representative of the knowledge, skill, and/or ability required.

**Education and/or Experience:** High school diploma or general education degree (GED) and previous experience preferred. In house training will be provided.

**Qualifications:** Must apply for, be granted and retain a valid Tribal Gaming License during their employment with Paragon Casino Resort. Must have understanding of and abide by all regulations as stated in the Tribal-State Compact.

**Language Skills:** Ability to read and comprehend simple instructions, short correspondence and memos.

**Mathematical Skills:** Ability to add and subtract two digits numbers and to multiply and divide with 10's and 100's.

**Reasoning Ability:** Ability to define problems, collect data, establish facts, and draw valid conclusions. Ability to interpret an extensive variety of technical instructions in mathematical or diagram form and deal with several abstract and concrete variables.

**Physical Demands:** The physical demands described here are representatives of those that must be met by an Associate to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the Associate is regularly required to talk or hear. The Associate is also regularly required to stand, walk sit and occasionally use hand to finger, handle or feel objects, tools or controls. The Associate is occasionally required to reach with hands and arms, and to sit, climb or balance and stoop, kneel, crouch or crawl.

The Associate must frequently lift and/or move up to twenty-five (25) pounds. The Associate is occasionally required to lift up to fifty (50) pounds.

Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception and the ability to adjust focus.

**WORK ENVIRONMENT:** The work environment characteristics described here are representative of those an Associate encounters while performing the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the Associate regularly works near moving mechanical parts and is exposed to industrial chemicals.

The noise level in the work environment is usually moderate to loud. The casino environment is usually smoky.
