#### **SUMMARY:**

Responsible for the deep cleaning of the stove hoods, equipment and floors in assigned food preparation venues when restaurant is closed for operation in accordance with Paragon Casino Resort specifications and standards.

#### **ESSENTIAL DUTIES AND RESPONSIBILITIES** include the following:

- Cleans all walls, surface of hoods, drains, rack areas and under equipment in food preparation areas.
- Cleans coolers and freezers.
- Cleans floors, drains, and sinks.
- Cleans kitchen equipment. Cleans kitchen grills after all food is removed.
- Cleans box room.
- Cleans interior walls of kitchens.
- Cleans soda machines, coffee machines and tea machines.
- Ensures adherence to all OSHA safety requirements, MSDS and company safety policies.
- Responsible for maintaining a clean and sanitary area at all times in full accordance with the Tunica-Biloxi Environmental Health department and State Health Regulations.
- Performs other duties as assigned.

#### ***Paragon Casino Resort requires all Associates to consistently:***

- To perform this job successfully, an individual must be able to perform each essential duty satisfactorily.

- Treat all Associates and Guests with respect, dignity, integrity and sensitivity.

- Support training and development for all Associates.

**Language Skills:** Ability to read and interpret documents such as safety rules, operating and maintenance instruction, and procedure manuals. Ability to respond to common inquiries or complaints.

**Mathematical Skills:** Ability to work with mathematical concepts such as addition, subtraction and multiplication tables.

**Physical Demands:** The physical demands described here are representatives of those that must be met by an Associate to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the Associate is regularly required to talk or hear. The Associate is also regularly required to stand; walk; sit; and use hands to finger, handle or feel objects, tools, or controls. The Associate is occasionally required to reach with hands and arms, and to sit; climb or balance; and stoop, kneel, crouch or crawl.

The Associate is required to lift and/or move up to seventy-five (75) pounds. Must be able to bend, lift equipment, and climb a twelve (12) foot ladder.

Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception, and the ability to adjust to focus.
